SPECIAL COMMODITY LEVY ACT, NO. 48 OF 2007

Order under Section 2

BY virtue of the powers vested in me under Section 2 of the Special Commodity Levy Act, No. 48 of 2007, I, Ranil Wickremesinghe, Minister of Finance, Economic Stabilization and National Policies of the Democratic Socialist Republic of Sri Lanka, do by this order impose in respect of the commodities specified in Column I of the Schedule hereto a Special Commodity Levy at the rate specified in the corresponding entries in Column II of that Schedule.

This Order shall be valid for a period of 06 months commencing from June 01, 2022 subject to provisions of Sub Section (3) of Section 2 of the special Commodity Levy Act, No. 48 of 2007.
