IMPORTS AND EXPORTS CONTROL ACT, NO. 1 OF 1969

IN terms of the powers vested in me by Section 20 read together with Sub-section 4(1) and Section 14 of the Imports and Exports (Control) Act, No. 1 of 1969 as amended by Act, No. 48 of 1985 and Act, No. 28 of 1987, I, Ranil Wickremesinghe, the Minister of Finance, Economic Stabilization and National Policies promulgate following Regulations.

Regulations

1. These Regulations may be cited as the “**Imports and Exports (Control) Regulations No. 20 of 2022**”.
2. The Special Imports License Regulations, published in the *Gazette No. 2044/40* dated November 09, 2017, as amended time to time, are hereby further amended.

3. Importation of following goods, classified under the **HS Heading of 88.03** and listed out in the **Schedule I** of the Special Imports License Regulations referred above, **by any Approved International Airline Operators for the purpose of Repairs/Maintenance of Aircrafts within the approved Customs Bonded Area**, on the recommendation of the Chairman or Director General of the Civil Aviation Authority of Sri Lanka, shall be exempted from the Imports Control License (ICL) requirement.

4. The recommendation of the Civil Aviation Authority, as specified in the Regulation No. 3, shall be submitted to;
- the Sri Lanka Customs for Customs clearing purpose, and
 - their licensed bank to release shipping documents and/or establish Letter of Credit (LC) and for effect the payment.
5. The Controller General, Department of Imports and Exports Control shall issue required "Operating Instructions" to the Director General, Sri Lanka Customs and licensed banks for effective implementation of these Regulations.
