Imports and Exports Control Act, No. 1 of 1969

IN terms of the powers vested in me by Section 20 read together with Sub-Section 4(1) and Section 14 of the Imports and Exports (Control) Act, No. 1 of 1969, as amended by Act, No. 48 of 1985 and Act, No. 28 of 1987, I, Ranil Wickremesinghe, the Minister of Finance, Economic Stabilization and National Policies, promulgate following Regulations.

REGULATIONS

1. These Regulations may be cited as the “**Imports and Exports (Control) Regulations No. 24 of 2022**”.
2. These Regulations shall enter into force with effect from December 20, 2022.
3. Imports and Exports (Control) Regulations No. 13 of 2022, published in the Gazette Extraordinary No. 2294/30 dated August 23, 2022, as amended, is hereby further amended.

3.1 Goods, described in the **Schedule D** of this Gazette shall be deleted from the **Schedule I** of Imports and Exports (Control) Regulations No. 13 of 2022, referred above.

3.2 As per provisions of the Customs Ordinance read together with the Government Revenue Protection (Special Provisions) Act, No. 01 of 2006, the Director General, Sri Lanka Customs is hereby authorized to release any Cargos / Consignments of goods specified in the **Schedule D** of this Gazette and arrived at any Port / Airport of Sri Lanka during the period of August 24, 2022 to December 19, 2022.

Imports and Exports (Control) Regulations No. 05 of 2020, published in the Gazette Extraordinary No. 2189/4 dated August 17, 2020, as amended by the Imports and Exports (Control) Regulations No. 14 of 2022, published in the Gazette Extraordinary No. 2296/30 dated September 09, 2022, is hereby further amended.

4.1 Goods, described below together with their corresponding entries shall be deleted from the **Schedule I** of the Imports and Exports (Control) Regulations No. 05 of 2020, as amended.

4.2 The Director General of Sri Lanka Customs shall allow Customs clearance of the said goods referred in the Regulation No. 4.1 above, arrived at any Port / Airport of Sri Lanka during the period of September 09, 2022 to December 19, 2022, subject to the Approval of Controller General of Imports and Exports.

5. The Controller General of Imports and Exports shall issue appropriate “Operational Instructions” to the Director General of Customs and the licensed banks for effective implementation of these Regulations.
